A Note on This Handbook

In October 20, 2015, National Economic Council (NEC) headed by the Honourable Prime Minister approved The Seventh Five Year Plan (FY2016-FY2020) entitled "Accelerating Growth, Empowering Citizens". The plan succeeded the Sixth Five Year Plan and serving as a principal document to continue the unfinished agenda of The Perspective Plan of Bangladesh: Making Vision 2021 a Reality. The Seventh Five Year Plan is a vast policy and strategic document encompassing a wide array of issues ranging from assessment of progress made in the Sixth Five Year Plan to macroeconomic framework to sector specific strategies setting quantitative and qualitative targets. For this reason, it is seemingly a colossal task to identify both quantitative and qualitative targets set in the plan by the respective Ministries/Divisions for implementation. It is worth mentioning that the Post 2015 Development Agenda has also been well integrated into the national plan document as the end of the Sixth Five Year Plan period and also the unfinished agenda of the Millennium Development Goals (MDGs) ended in 2015. The Seventh Five Year Plan is the first plan to be implemented, aiming at the Sustainable Development Goals (SDGs). In order to have more coordinated, and result based actions, it is essentially important to pinpoint the targets embodied in the plan for each Ministry/Division. Keeping specifically this in mind, General Economics Division (GED) took an initiative on how to facilitate the Ministries/Divisions outlining/fixing their own specific targets to be attained under the seventh plan, which we called A Handbook of the Seventh Five Year Plan, specifying tasks to be accomplished by each Ministry/Division. To say briefly, this is a quick aid to help one to understand in taking grasp of the Ministry's tasks to be accomplished as of the Five Year Planning tool. GED first picked up/ identified the relevant targets for each Ministry/Division. Then Ministries/Divisions were asked for feedback of the draft, whether there is any missing or subtractions in the indicated targets. Out of 53 Ministries/Divisions, feedbacks of 23 were received. Upon receiving feedback, the GED team scrutinized inputs of Ministries/Divisions whether there is any inaccuracy or redundancies. Having this Handbook, the Ministries/Division no longer would need to go through the entire document to search for their respective task to be accomplished. This is so because the whole plan was organised in 13 thematic sectors not by ministries. The Handbook can act as guidelines for identifying future projects/programmes in attainting quantitative and qualitative targets. Besides, the Ministries/ Divisions can use it to monitor the progress based on set targets underlined in the Seventh Five Year Plan, as many of the targets are quantifiably measureable. The Handbook is the first of its kind since the introduction of Five-Year Planning tool in Bangladesh. Actually this document was prepared to aid training participants on the 7th FYP and SDGs to be acquinted with their respective Ministrie's objectives/targets to be attained during the plan period.

GED hopes the Ministries/Divisions will take this Handbook seriously and expedite actions to implement their respective tasks. GED acknowledges the contribution of all the officials of the relevant Ministries/Divisions for their assistance in preparing the Handbook on 7th FYP. This Handbook was made possible by the efforts of most of GED officials worked under the leadership and guidance of Dr. Shamsul Alam, Member (Senior Secretary), GED. GED hopes that this Handbook will largely facilitate implementation of the 7th FYP to fulfil its delineated national goals and targets. GED would like to appreciate the support in printing the hand book through the Project titled "Preparation and Monitoring of Medium Term Development Plans (7th Five Year Plan)' being implemented by GED.
